- **(c)** NA3 Development Framework Plan it was noted that progress on the Development Framework continued and that representatives of the Town Council were in dialogue with staff of the District Council on the matter. It was suggested that the allocation had a number of sensitive issues to consider, including environmental issues such as the Wolborough Fen; traffic congestion and pollution; together with its relationship to Wolborough Church.
- **(d) Greater Exeter Strategic Plan –** Members discussed the recent consultation exercise held by Teignbridge District Council regarding a Greater Exeter Strategic Plan (GESP) which included the administrative areas of Exeter City Council; Teignbridge District Council; East Devon District Council; and Mid Devon District Council but excluding the Dartmoor National Park. The intention was that the GESP would be an overarching plan to the Local Plans of those four Councils. Creation of the Plan would require five stages, comments being invited on Stage 1, Issues and Calls for Sites, responses to which were required to be submitted by 10th April 2017.

The Committee expressed its concerns that another Plan should be proposed which would sit above the current Teignbridge Local Plan which had been created following a great deal of consultation with the people of Teignbridge. Concerns were also expressed that the currently allocated developments in Newton Abbot were the maximum the area could absorb and therefore nothing further should be allocated in the GESP.

Councillor M Hocking had attended a public consultation event on 23rd March regarding Stage 1 of the Plan and as a result had written a draft proposed response. The draft had been sent to all Members of the Council via e-mail in advance of the meeting for their consideration.

Arising from a detailed discussion on the above it was

RESOLVED that the Town Clerk liaise with Councillor M Hocking with a view to utilising Councillor Hocking's draft response as the basis of the Town Council's view on Stage 1 of the Greater Exeter Strategic Plan.
