65. **UK SHARED PROSPERITY FUND**

Further to Minute 24/06(33) the Mayor reminded Councillors this matter had been deferred from the previous meeting while clarification was sought on how the funding could be spent:

*Minute number 24/06(33) In principle, Councillors were in support of using the funding for the benefit of the whole town and requested further clarification on spending. Councillor Bullivant agreed to withdraw the proposal and confirmed the Newton Abbot & Kingsteignton Garden Community Board will provide additional clarification on the funding ahead of the Full Council meeting on the 19<sup>th</sup> June 2024.*

The Mayor invited Councillor Bullivant to provide an update. Councillor Bullivant reported that the UK Shared Prosperity Fund (UKSPF) guidelines allow funding for an event in Queen Street, as long as it included a market, but not for marketing materials. Councillors questioned the feasibility of the market given the new street reconfiguration and its limited support for all traders affected by the current town disruptions.

The Town Clerk confirmed the funding became available due to underutilisation by another town in the District, noting the funding comes with several conditions. It was suggested that the District Council, as the Markets Authority, should facilitate the Christmas Market. Arising from the discussions, it was:

**RESOLVED** that the Town Council hereby declines the proposal from the Newton Abbot & Kingsteignton Garden Community to deliver an event in Queen Street using additional UK Shared Prosperity Funding.
